1. Introductory paragraph

BrainWaves is a new registered charity (number: 1213437) created to lead a project about mental health and wellbeing. BrainWaves is run by the University of Oxford, in partnership with Swansea University and *The Day* (a digital publisher for schools). BrainWaves aims to investigate young people's mental health in order to improve the quality of scientific knowledge surrounding this research area and assist young people with the management of their mental health challenges. We are inviting you to continue your participation in this cohort study since you have previously taken part. The study consists of annual online questionnaires to help us learn more about young people's mental health and wellbeing. In addition, we will send you a study update every few months. We may also invite you to take part in other BrainWaves studies, but for these we won't contact you more than twice a year.

Before you decide whether to take part in this study again, it is important for you to understand why the research is being done and what it will involve. Please take time to read the following information carefully and discuss it with others if you wish. You are welcome to contact a member of the research team (please see details below) if there is anything that is not clear or if you would like more information. Note that all questionnaire data will be pseudonymised. This means that data will be labelled with a code instead of your personal details and a linkage key will be stored separately on secure servers.

2. Why is this research being conducted?

- To help us understand how best to promote mental health and wellbeing in young people.
- To provide researchers with in-depth knowledge on young people's mental health.
- To inform the development of interventions to promote good mental health.
- To inform the development of teaching materials that support good mental health.

3. Why have I been invited to take part?

• You have been invited to take part in this questionnaire because you previously participated in the BrainWaves project while still in school. We are now inviting you to continue your participation and take part in this follow-up questionnaire.

4. Do I have to take part?

- No, you do not have to take part if you don't want to.
- If you do decide to take part and then change your mind, you can stop taking part at any time without giving a reason.

5. What will happen to me if I take part in the research?

We'll ask you to log back into the account you created previously (there is an option for forgotten passwords). You will then be asked to complete the annual online questionnaire about your mental health and wellbeing. We will also ask you to provide your mobile phone number as a backup contact method. We suggest that you allocate approximately 20 minutes in total to answer this questionnaire. The questionnaire will ask you about the following topics:

- Mental health
- Wellbeing
- Lifestyle, including substance use, self-harm and eating behaviour
- Cognition (thinking processes)
- Health
- Adversity you may have experienced (such as maltreatment and abuse)
- Social relationships, including sexual and romantic relationships

6. What are the possible disadvantages and risks in taking part?

Some of the questions may be sensitive or distressing, but we ask about these topics because we know from previous research that difficult life experiences such as maltreatment or discrimination affect mental health in young people.

- You always have the option to not answer questions or sections if you do not want to.
- If you are upset or concerned about any of the questions, we encourage you to reach out to a trusted adult at home or elsewhere. We provide some links to online resources at the end of the questionnaire. You will also be provided with the option to request to be contacted by someone about some of the questions. When contacted, you will be given some options to choose from to receive further support, including a referral letter to take to your GP, an initial phone call with a chartered psychologist (a member of the BrainWaves team), or further online self-help materials. We will contact you within 5 working days of you requesting support and we will make 3 attempts to reach you.

7. Are there any benefits in taking part?

Being part of BrainWaves is something that helps others. You will be giving your time and data to help researchers make discoveries about young people's mental health and wellbeing, and to develop better ways of supporting young people in their journey to adulthood. This will allow yours and future generations to live happier and more fulfilling lives.

You will also be given the opportunity to enter a prize draw upon completion of the questionnaire. You will have the opportunity to win one of 10 prizes. Clear instructions will be given on the online data portal as to how to enter the competition as well as the terms and conditions. Your entry into the competition will be kept separate from your answers to the questionnaire and we will not be able to link your questionnaire responses to your competition entry. The winners will be chosen at random one week after the completion of the data collection window.

8. Expenses and payments

There will be no payment for taking part in this research.

9. What information will be collected and why is this information relevant to the study? Data processing and storage are fully automated through trusted online research platforms at Swansea University. We will collect the following data:

Consent forms

o Why? To learn about who does and does not give consent to take part in research.

- For how long? Indefinitely, so that we can always demonstrate participants' consent to take part in the research.
- Who will have access? System administrators, information compliance teams, auditing firms and the BrainWaves study team members. Consent forms will not be shared outside of the study.

Identifiable information (such as your contact details and education records)

- Why? To link your responses over time as part of the wider BrainWaves Study. In the
 future, we may also link your education records to data collected from this
 questionnaire in order to gather valuable information about how these aspects may
 be related.
- For how long? For the duration of the study (at least 10 years), unless you ask us to remove them.
- Who will have access? Only system administrators at Swansea University will have access to these (for the purposes of linking your responses). Researchers will not have access to these.

Contact details

- o Why? To be able to recontact you for future phases of the BrainWaves Study.
- For how long? For the duration of the study (at least 10 years), unless you ask us to remove them.
- Who will have access? The BrainWaves Study team will have access to these details but we will not share them beyond the study without your permission..

Questionnaire data (including data on your basic demographics (e.g., gender, age), and health and wellbeing, see section 5)

- o Why? To explore key issues and trends in youth mental health and wellbeing.
- For how long? Data will be kept in pseudonymised form (i.e., without your name or email) indefinitely so that we can continue to learn from them.
- Who will have access? The BrainWaves Study team and approved researchers will
 have access to your pseudonymised questionnaire data. As The Day is only
 responsible for recruiting participants, they will not act as data processors and
 therefore, will not have any access to the data.
- If you want your questionnaire data to be deleted from our platform, you can contact the team at brainwaves@psych.ox.ac.uk with your request. Please note that data cannot be removed from analyses that are completed or underway.

10. Will the research be published? Could I be identified from any publications or other research outputs?

Findings from the research will be used exclusively for research purposes and may be published in academic publications, conference presentations, and summaries for students, schools, and the general public. All findings are screened to ensure that individuals are not identifiable.

11. Data Protection

The University of Oxford is the data controller with respect to your personal data, and as such will determine how your personal data is used in the research. The University will process your personal data for the purpose of the research outlined above. Research is a task that is performed in the

12. Who is funding the research?

This study is funded through philanthropic (donated) support to the BrainWaves project.

13. Who has reviewed this research?
